

# WOMEN'S WORLD MATCH RACING TOUR 2024 NOTICE OF TOUR

#### 1 GOVERNING ORGANIZATION

The Governing Organization (GO) will be the Women's World Match Racing Tour (WWMRT).

#### 2 ORGANIZING AUTHORITY

The Organizing Authority (OA) for each event will be the clubs/organizers of each event on the 2024 WWMRT.

#### 3 RULES

The Notice of Races and Sailing Instructions for each event shall apply.

#### 4 2024 SCHEDULE OF EVENTS (Note: Race Days only)

- Stage 1 Santa Maria Cup, Eastport Yacht Club, Annapolis, USA, 23-26 April
- Stage 2 Casa Vela Cup, St. Francis Yacht Club, San Francisco, USA, 2-5 May
- Stage 3 Normandy Match Cup, Le Havre, France, 17-20 May
- Stage 4 Nordea Trophy Match Cup Sweden, Marstrand, Sweden, 1-6 July
- Stage 5 KDY Women's Match Race, Skovshoved, Denmark, 5-8 Sept

Additional stages may be added, notification will be made before 1 April 2024.

## 5 TOUR SCORING

- (a) A team's Tour points total will be the sum of their best three (3) scores.
- (b) The team with the highest score at the end of the season will be the 2024 Women's World Match Racing Tour Champion.
- (c) If RRS 2021-2024 rule C11 doesn't solve a tie at an event, the remaining tie(s) will be solved by using: the points for the place for which the teams have tied and for the place(s) immediately below shall be added together and divided equally amongst the tied teams.





(d) Series Points Table (awarded per event)

- (e) In the event of a tie at the end of the Series, the tie shall be broken by the following methods, in order until all ties are broken. When one or more ties are only partially broken, the methods shall be reapplied to them. Ties shall be decided in favor of the team(s) which:
  - a. Has the greater number of first place scores. If the tie remains then the number of second place scores, and so on until the tie is broken;
  - b. Has the highest score in the last event. If the tie remains it will be broken by using the scores in the next-to-last event and so on until the tie is broken (if a team did not sail an event, they shall be awarded a zero score for the purposes of this tie break).

## 6 ENTRIES

- (a) Each event on the WWMRT will have places for at least 8 teams. Events may increase the number of teams.
- (b) Skippers who request an invitation to all Tour stages shall be given priority for acceptance at each Tour stage.
- (c) WWMRT requests those teams to notify the WWMRT (<a href="info@wmrt.com">info@wmrt.com</a>) of their commitment to enter those selected events at the same time they notify the individual events. WWMRT will then notify the selected events of the team's commitment so the risk of miscommunication will be minimized and the opportunity to be accommodated at the events will be maximized.



- (d) Neither the individual events of the WWMRT nor the WWMRT organization can guarantee that all teams which commit to participate in all events will be invited to those events because of the number of teams that may need to be accommodated and because each event has its own invitation policy. However, the events and WWMRT will use their best efforts to accommodate those teams which do make that commitment. The earlier that a team makes a commitment to enter all events, the greater the chance that team will have of being accommodated.
- (e) All competitors competing in the WWMRT shall be current members of the Women's International Match Racing Association (WIMRA)

## 7 PRIZES

The winner of the 2024 WWMRT will be presented the Women's World Match Racing Tour Championship Trophy. Additional prizes may be added.

The WWMRT have the right to use any images, footage and sound recorded during the WWMRT events free of any charge.
